#### **BIODIVERSITY POLICY**

We recognize the impact of operations on biodiversity is a material aspect for Alliance, as such are committed to conserving the nature and contribute positively to biodiversity through creation, enhancement, and management of habitat.

- Carefully select site locations to avoid high-biodiversity value areas;
- Engage environmental experts for the environmental assessment when planning for new sites, which will identify possible impacts on biodiversity and thereby the development of effective mitigation plan and measures to minimize them;
- Embed biodiversity management into quarry development and restoration plans and to monitor their implementation;
- Promote biodiversity conservation in the quarry sites and to educate employees and site contractors concepts and practices on biodiversity and management of habitat;
- Engage stakeholders such as local communities and professional institutions for collaborative actions to protect the habitat and enhancement of biodiversity knowledge.

This policy shall apply to all sites including joint venture sites where Alliance has operation controls. At our non-operated sites we'll share our performance requirements and support these sites to adopt them.

#### WATER POLICY
